ACEC PRESIDENT'S UPDATE

Following our successful Fall Conference in Scottsdale in October, the Council has kept up the pace in November with our annual Leadership Orientations for state MO and Coalition leaders in Washington, D.C. We focused on national/state collaboration for maximum mutual gain. In our government advocacy and political programs, we secured improvements to the SEC municipal advisor rule, and we continue to work with the agency to further clarify engineering activities that should be exempt from registration requirements. Lawmakers on both sides of the aisle continue to express optimism that WRRDA -- which includes several ACEC-backed provisions -- will be finalized before the end of the year, and we are pressing budget conferees to protect key federal infrastructure accounts and include funding for MAP-21 reauthorization and other critical programs as they try to reach agreement on a long-term budget deal.

- Urged House and Senate budget conferees to protect the Highway Trust Fund and replace the mandated, across-the-board spending cuts (sequestration) with a more targeted deficit reduction plan.
- The House Judiciary Committee passed ACEC-backed legislation the Innovation Act to protect engineering firms and other businesses from so-called patent "trolls".
- The Securities and Exchange Commission (SEC) published its final "municipal advisor" rule which broadened and clarified the engineering exemption language to protect firms from registration requirements.
- Promoted public-private partnerships in facilitating infrastructure development and improving government service on an expert panel hosted by the new Congressional P3 Caucus, formed by Reps. Gerry Connelly (D-VA) and Mike Rogers (R-AL).
- Launched grassroots action alert to defend the ability of engineering firms to use the cash method of accounting and

push back against proposed House legislation to limit its use.

- Endorsed legislation to create a new national infrastructure financing authority, introduced by Senators Warner (D-VA) and Blunt (R-MO), which would be capitalized with \$10 billion and provide loans and loan guarantees for major transportation, water and energy projects.
- Endorsed the North American Energy Infrastructure Act, which consolidates and standardizes the cross-border permitting process for oil pipelines, natural gas pipelines and electric transmission lines.
- The House cleared a series of ACEC-backed energy bills to expand energy exploration and production on federal lands, preserve the ability of states to regulate hydraulic "fracturing" in natural gas development, and streamline the permitting process for natural gas pipelines.
- Endorsed the Water Protection and Reinvestment Trust Fund Act to create dedicated tax revenues to support water infrastructure projects.
