# ACEC/MS PRESIDENT'S MESSAGE

Time is relentless. The Deep South Convention is rapidly approaching and will be held once again in Sandestin on July 26-28. If you have not made plans to attend, it is not too late to do so. There will be a great lineup of speakers and activities for all. Also be sure to mark August 17<sup>th</sup> on your calendar for Roosevelt Day.

Breaking news from ACEC is the naming of a new national President. Wayne Morrison will travel to Washington, D.C. to represent ACEC/MS at a Special ACEC Board meeting to ratify the selection of a very capable successor to Dave Raymond who has served ACEC with dignity and distinction for over 19 years.

On the state level, it appears that the Governor is working toward a special session to address funding for roads and bridges. Once again, the call appears to be contingent upon a tentative agreement by leadership of the House and Senate.

Other notable news at the state level is an appeal to the U.S. Fifth Circuit Court of Appeals regarding a decision in Federal District Court regarding use of the name "Tire Engineers" by a chain auto repair/tire company. The case was brought by the State Board of Registration after negotiations with the company broke down. Upon a request from the Registration Board and the Mississippi Attorney General, NSPE, ASCE and ACEC/MS have joined forces to produce an Amicus Brief in support of the court decision. ACEC/MS has committed up to \$5,000 in support of the effort and is requesting a 1:1 match from the ACEC Minute Man Fund. In reviewing such requests, the track record of PAC and Minute Man Fund contributions are taken into account - which brings up another relevant topic.

The annual PAC goal for ACEC/MS is typically around \$12,000. For the past several years we have come close, but not quite met the goal, which only amounts to an average of about \$125 per member firm. The ACEC/MS leadership is proposing a three-year goal to bring national recognition to ACEC/MS as a PAC leader nation-wide. The initial step is to meet or exceed the 2018 goal. The next step is to meet the 2019 goal by April 1, 2019 so that the state is recognized at the 2019 Spring Conference in Washington, D.C. The final goal is to meet the 2020 goal by the first day of the year. Currently ACEC/Indiana achieves this and we would like to join them.

I would like to thank all those who unselfishly gave of their time and talents to support ACEC/MS in this transitional year. The strength of the organization is truly in those member and affiliate member firms and organizations that actively participate. I encourage all members to be active and involved to make our organization stronger and more effective.

Special thanks are in order to Allen Scott, who will be serving as ACEC/MS President for 2018 -2019, and the Board of Directors- Wayne Morrison, Kyle Wallace, Randy Ahlrich, Dax Alexander, Scott Burge, our National Director David Bowman and our PAC Chairman Hunter Arnold Last, but by no means least, we are grateful for an outstanding leadership team in Craig Carter and Jessica Gosa our Executive Director and Office Manager. Thank you both for your service to our organization.

Finally, one of the greatest benefits of serving as ACEC/MS President is the opportunity afforded to become better acquainted with colleagues around the state. For this I will be forever grateful. It has been an honor and privilege.

# **GOVERNOR PHIL BRYANT APPOINTS** HARRY LEE JAMES STATE AID **ENGINEER AT MISSISSIPPI OFFICE OF** STATE AID ROAD CONSTRUCTION

Gov. Phil Bryant announced today that he has appointed Harry Lee James state aid engineer in the Mississippi Office of State Aid Road Construction.

James replaces Carey Webb, who has worked in various capacities at the Office of State Aid Road Construction for 29 years. Webb has been state aid engineer since 2012.

"Carey Webb has faithfully served the people of Mississippi at the Office of State Aid Road Construction for almost 30 years, and I wish him well upon his retirement," Gov. Bryant said.

James first went to work at the Mississippi Department of Transportation in 1982, as an engineer in the agency's Bridge Division, a role he served in until 1999. He served as MDOT's state bridge engineer until 2003. From 2003-2008, he was deputy director and chief engineer in MDOT's Office of Highways. He joined the private sector in 2009, as executive director of the Mississippi Concrete Industries Association. Since 2016, James has served as a consultant to the Office of State Aid Road Construction. "Harry Lee James' decades of experience planning, designing and maintaining Mississippi roads and bridges make him the perfect fit to lead the Office of State Aid Construction," Gov. Bryant said. "I am pleased he has accepted this appointment." James earned a bachelor's degree in civil engineering from Mississippi State University in 1976. He is a registered professional engineer and registered professional land surveyor.

"I am honored to serve as state aid engineer and appreciate the governor's confidence in appointing me to this position," James said. "I look forward to serving Mississippi and working with the men and women of the Office of State Aid Road Construction as we keep Mississippi moving forward."

James is a 2003 graduate of Indiana University's National Transportation Leadership Institute. In 2004, he was recognized as a Distinguished Fellow of Mississippi State's Bagley College of Engineering. He was the Mississippi Engineering Society's Engineer of the Year in 2005.
