HB354 General fund revenue; provide that percent of growth in will be used for repair and maintenance of state and local roads. 01/03 (H) Title Suff Do Pass Any year when revenue growth to the state General Fund exceeds 2%, House Bill 354 would take half that growth above 2% up to \$100 million and use it for road and bridge maintenance. Majority of that money would go to the state with smaller shares to counties and cities. General Fund has exceeded 2% only in five of the last 10 years.

Passed As Amended This is the internet sales tax bill I sent you yesterday that passed the House. It gives the revenue to cities, counties and MDA. The total revenue that will be distributed is around \$109 million that goes into the General Fund. So, for anything to further develop on this bill they must figure out a way to plug the general fund.
